

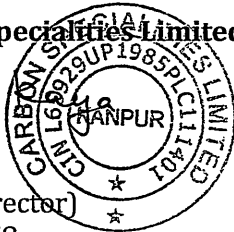

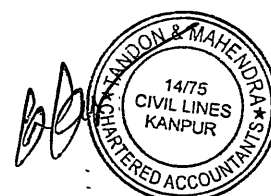
Introduction

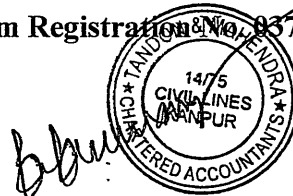
